## Audition Application Information/Terms and Conditions

1. There is a €20 charge to enter the competition which is payable at your first audition. This payment is non refundable whether you do or do not make it past the first audition stage. No audition will be seen unless registration and payment is made at the first audition. This charge is necessary to cover the administration costs for the audition stages of the competition.
2. This competition is NOT open to any professional performers. The Organiser, John Drummey Communications, deems any person or persons who are under agreement or contract to any agent, agency or company for the purpose of performing or recording are professional. Also the Organiser deems that any person who derives the majority of their income from their act/talent is considered a professional and thus may not enter this competition.
3. All contestants must be resident in Co. Clare. Contestants may be asked by the Organiser for proof of address which must be a postal address and primary place of dwelling within the County Bounds.
4. Family members of an employee of the Organiser or its associate promotion partner, Clare FM, are not permitted to enter this Competition
5. The information given by you in your application may be used in the competition should you be selected.
6. You acknowledge and agree to abide by the rules regulations terms and conditions for this competition as determined by the Organiser (the "Rules") and that the rules may be changed (including without limitation verbally) at any time by the Organiser and that you will bound by such rules. The Organiser's decisions shall be final.
7. Each applicant/act will only be offered one opportunity to audition. You may audition as a solo artist or part of a group BUT not both.
8. John Drummey Communications, their agents, associate promotion partner and sub contractors do not accept any responsibility whatsoever for any technical clerical error or malfunction resulting in your application to enter not being received or processed on time and thus resulting in you not being accepted into the competition.
9. Applicants will be selected at the sole discretion of the Organiser whose decision will be final. The Organiser does not guarantee that all applicants will be contacted.
10. If you are under 18 years old you must be accompanied by your parent or legal guardian at the audition and subsequently if selected at all other stages of the competition.
11. You may be asked by the Organiser to provide documentation to substantiate your age (ie birth certificate and/or valid passport).
12. All personal details and/or information given in your application either in this form or otherwise must be truthful, accurate and in no way misleading.
13. The Organiser reserves the right to disqualify you if you have supplied untruthful, inaccurate or misleading personal details and/or information, have failed to abide by the rules and/or are in breach of the terms hereof.

You will not, without the Organiser's prior written consent, publicise or discuss with any third party any information relating to the competition, your appearance, the production team or any participants in the programme nor any other information which may come to your attention including without limitation in relation to the broadcaster, the organisers or otherwise save where such information is already public knowledge.

You will be responsible for bringing such equipment (provided it is suitable for the audition location) and are responsible for ensuring that such equipment is safe and/or suitable for its purposes. Pyrotechnics are not permitted.
